The decision was made this year to relocate AITP off Main Street where access created a variety of problems. Flat Iron Park is located just around the “corner” from Library Park on our beautiful lakefront. Here we will be able to provide reserved parking for our exhibitors adjacent to the Park. This area will be closed off to traffic during unloading & loading. The City of Lake Geneva is a summer resort area frequented by affluent crowds from the Chicago and Milwaukee areas. Many of these visitors stay in the four hotels on the east side of the Park and in the large condominium residence to the north. The shopping district is just a block away. These visitors look forward to Art in the Park each year and we feel this new location will make it more convenient for all.

Eligibility

All works must be original in concept and design and must have been executed by the applicant; work from molds or kits, commercial or manufactured items, and mass produced items are not permitted. Media is limited to Fine Art/ Fine Craft in the categories noted on the Prospectus.

Exhibition Rules

1. Each exhibitor is responsible for providing and assembling his/her own display and un-loading & loading.
2. Set up time is 6:00-9:30 a.m. Saturday.
3. Exhibits must be set up before 10:00 a.m. Saturday and not taken down before 4:00 p.m. on Sunday. Any exhibitor disbanding an exhibit before 5:00 p.m. on Saturday will not be permitted to return on Sunday. “No shows” and exhibitors who leave the show early will be disqualified from future exhibitions.
4. All exhibitors are required to be present both days - Sales Representatives are not allowed.
5. **Our preferred method of communication with you will be via Email, so it is important that we can read your address and that you update us if it changes.**
6. Items that do not represent media and quality of work of your submittal may not be exhibited in your booth. You may exhibit only in the **ONE** media category accepted through the jurying procedure.
7. Work must be appropriately framed for exhibition.

Exhibition Rules (cont.)

8. Commercial Reproductions of original work are acceptable only under the following criteria:
 - Limited to 20% of the total display
 - All must be signed, limited editions
 - All must be clearly marked as a reproduction
 - Duplicate images cannot be displayed simultaneously and must be kept separate from original work
 - Cards and reproductions of exhibiting artist's work are permitted if they are not more than 20% of the total display.
9. Artists are encouraged to demonstrate their medium before the public.
10. Toilet facilities are located at the north end of the park.
11. There will be no refunds for cancellation, removal for cause, bad weather or other acts of nature. Exceptions may be made for highly unusual circumstances at the discretion of GLAA.
12. There is no rain date.
13. Municipal ordinances prohibit alcohol & animals in the park.
14. Spaces are 10' x 10'.
15. Each artist assumes full responsibility for the care, safety, and security of their work and property. The Geneva Lake Art Association, its Board of Directors and Members, and the City of Lake Geneva assume no responsibility or liability for accidental damage, theft, vandalism or lost property. Application by the artist for participation in Art in the Park indicates the applicant's agreement with all terms contained herein.
16. GLAA will greatly appreciate your help in keeping your site clean at all times.
17. Applicants must be 18 years or older.

Entry Fees

1. A non refundable jury fee of \$15 must be submitted with registration forms post marked prior to March 1st. After March 1st a non refundable jury fee of \$25 must be submitted with registration forms due March 31st.
2. A jury fee is not required for winners from the 2009 show provided the registration form and booth fee are submitted.)
3. A required \$180 fee for a 10x10 ft space is to be your second check.
4. If you are requesting a corner space, please include a third check in the amount of \$25.00
5. If you are not accepted, the booth fee check and corner fee checks will be returned to you.
- 6. There will be no booth fee refunds to accepted applicants after March 31st.**

Judge

This year's judge is artist and teacher Rosalie Beck.

Cash Awards

(1) Best of Show \$500, (5) Awards of Merit @ \$200. The awards will be presented Saturday.

Location

Flat Park, on the lake front between Center Street and Wrigley Drive just south of Main Street, downtown Lake Geneva, WI. (Just around the lake shore from Library Park)

Parking

If you have a standard size vehicle/van you will be assigned a parking space adjacent to the park. Oversized vehicles may be required to unload and move their vehicles to a reserved space a few blocks away. The street will be blocked off during unloading and loading times. If accepted, more information will be provided.

Security

Police security will be provided Saturday from 6 p.m. through 8 a.m. Sunday morning for the purpose of leaving display units set up. If art work is left in the tents overnight, GLAA assumes no responsibility for damage, theft or vandalism. For security reasons the police request your cell phone number in case of an emergency.

Silent Auction

Exhibitors who donate a piece of their art work for our silent auction will have a special mention in our brochure as well as a special designation on their booth sign. The auction will be held at 2:00 pm on Sunday. Please indicate your participation in the application.

State Sales Tax

All proceeds from sales made by exhibitors will be retained by the exhibitor. However, exhibitors must charge and collect 5 ½% sales tax on each sale. This money must be submitted to the Wisconsin State Sales and Excise Tax Division. Forms and information will be distributed to you with your information package.

Submission of Entries

All participants, (with the exception of award winners from the previous year), will be juried using digital images. A total of **six** digital images must be submitted: **Five** images must be of your current work and **One** of your booth showing items displayed. Digital images must be high quality JPEGs with a recommended resolution of 300 dpi and file size no larger than 5 megabytes. Submit all images on a single CD and label each file accordingly: *Last name _media_ entry number*. Clearly label the outside of the CD with the entrants name and media. Include an 8 ½" x 11" reference sheet with prints representing the images on the disc.
